In 2020, despite the pandemic, Reach Out and Read was delivered in more than 227,000 "doses" at well child visits in 325 Colorado clinics across all Colorado counties, delivering a new, developmentally- and language-appropriate book and anticipatory guidance to the families of approximately 114,000 children ages five and under, as delivered by the nearly 2,000 healthcare providers trained in the program, as well as the clinical staff supporting them. Together, they represent more than 55,000 volunteer hours spent delivering this early literacy intervention in a professional healthcare setting to children and families with the highest need. In 2020, approximately 75% of children served come from families experiencing poverty.
